



## YOUTH MONTH COLORING CONTEST & DEPOSIT RAFFLE

### OFFICIAL CONTEST RULES

**PROMOTION DESCRIPTION.** The Youth Month Coloring Contest consists of an in-branch Contest (the "Coloring Contest Promotion"). The Youth Month Deposit Raffle consists of an in-branch contest (the "Youth Month Deposit Raffle Promotion"). Both Promotions begin on 04/03/23 at 09:00:00 AM (MT) and end on 04/28/23 at 06:00:00 PM (MT) ("Promotion Period"). These Promotions are being facilitated by Clarity Credit Union (the "Sponsor"). NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

**ELIGIBILITY:** The Coloring Contest is open only to those who visit one of the Clarity Credit Union branches and obtain an age specific coloring contest sheet. The Deposit Raffle is open only to those members ages 17 and younger who make a deposit into their account and fill out a raffle ticket. Employees of Clarity Credit Union, subsidiaries, affiliates, advertising and promotion agencies, participating retailers and immediate family members and/or those living in the same household of each are not eligible to participate. Void where prohibited.

**TO ENTER THE COLORING CONTEST:** During the Promotion Period, 1) Parents or youth can obtain an age specific coloring contest sheet 2) Return the colored sheet to the branch during the promotion period with all information complete and legible. Registration is free. Contestants must enter by 04/28/2023 at 06:00:00 PM (MT). Limit one (1) entry per person for the Promotion Period.

**TO ENTER THE DEPOSIT RAFFLE:** During the Promotion Period, 1) Youth ages 17 and younger can visit a branch and make a deposit into their account. 2) For each deposit made during the Promotion Period, youth members can fill out a raffle ticket with all information complete and legible. Registration is free. Contestants must enter by 04/28/2023 at 06:00:00 PM (MT). The number of entries allowed cannot exceed the number of deposits made during the Promotion Period.

**COLORING CONTEST WINNER SELECTION:** Each branch will choose one winner from each age category on 05/01/2023 from among all eligible entries received by the Sponsor or its designee, the judges in this Promotion, whose decisions are final and binding. Winner will be notified by branch staff at sponsor discretion.



**DEPOSIT RAFFLE SELECTION:** Every branch will send their raffle tickets into the Marketing department of Clarity Credit Union. One (1) winner will be randomly drawn 05/01/2023 from among all eligible entries received by the Sponsor or its designee, the judges in this Promotion, whose decisions are final and binding. Winner will be notified by branch staff at sponsor discretion.

**PRIZES/APPROXIMATE RETAIL VALUE (ARV)/ODDS:** Coloring Contest Prizes: A twenty-five dollar (\$25) Clarity Visa gift card will be awarded to each age category winner at each branch. Total Approximate Retail Value ("ARV") is \$25. Deposit Raffle Prizes: A \$50 gift card to Zoo Boise and other Discovery Kids learning activities. Total Approximate Value ("ARV") is \$125.
