



CMN HELICOPTER BALL DROP

OFFICIAL CONTEST RULES

PROMOTION DESCRIPTION. The CMN Helicopter Ball Drop consists of an in-branch Contest (the "CMN Helicopter Ball Drop"). The Promotion begins on 08/01/24 and ends on 09/13/24 at 06:00:00 PM (MT) ("Promotion Period"). This Promotion is being facilitated by Clarity Credit Union (the "Sponsor").

ELIGIBILITY: The CMN Helicopter Ball Drop is open only to anyone ages 18 and over, who visits one of the Clarity Credit Union branches and makes a donation of \$10 to CMN for each helicopter ball drop number. Void where prohibited.

TO ENTER: During the Promotion Period, 1) Anyone who is eligible to participate can visit a branch and make a \$10 donation to CMN. 2) For each \$10 donation made during the Promotion Period, participants will receive a number for a corresponding golf ball that will be dropped out of the helicopter on September 20, 2024. Contestants must enter by 09/13/2024 at 06:00:00 PM (MT). The number of entries allowed is not capped.

WINNER SELECTION: A list of all entries will be provided to the Marketing department of Clarity Credit Union. Golf balls with corresponding numbers will be provided to the aviation company. All golf balls will be dropped out of the helicopter at the same time. One (1) winner will be selected by determining that the ball went into the hole or is the closest to the pin. In the event of a tie, the ball at the bottom of the hole, or the first deemed to have entered, will be proclaimed the winner. If no balls are in the hole the winner will be selected by measuring the distance in proximity to the pin. In the event of a tie in exact measurement from the pin, the prize money will be divided equally. The judges in this Promotion, whose decisions are final and binding will be a member of the Clarity Credit Union marketing department and a staff member from Falcon Crest Golf Course. Winner will be notified by branch staff at sponsor discretion.

PRIZES/APPROXIMATE RETAIL VALUE (ARV)/ODDS: A cash prize totaling half of the overall money contributed OR a minimum of \$300 cash will be the prize of this contest. Total Approximate Retail Value ("ARV") is \$300+. Unclaimed prizes will not be awarded. All applicable federal, state, and local tax liabilities (including income taxes) arising from this Promotion will be the sole responsibility of the prize winner. Odds of winning depend on the number of entries. For example, if 1,000 entries are received, the odds of winning would be 1 in 1,000.

If prize notification is unanswered by 10/02/2024 at 09:00:00 AM (MT), prize may be forfeited and will be donated to CMN. No correspondence will be acknowledged.
