

OFFICIAL CONTEST RULES

1. Contest Dates/Eligibility. Clarity Credit Union is in charge of the Dog Days of Summer 2025 Contest. The contest, beginning June 23, 2025, and ending July 31, 2025 will include weekly drawings on July 3, 2025, July 11th, 2025, July 18, 2025, July 25, 2025, and July 31, 2025. All participants are eligible to re-enter the contest every Monday throughout July for another chance to win. We retain the right to change the dates and/or the terms of the contest without prior notice. There is no purchase necessary to enter or win. A purchase will not increase a contestant's chance of winning. This contest is void where prohibited by law. Employees or agents of Clarity Credit Union, or any entity associated with the sponsorship or administration of the contest, are ineligible to participate.

2. How to Enter. Beginning June 23, 2025 and continuing until July 31, 2025, participants must leave a comment on our contest post at our Facebook page <https://www.facebook.com/ClarityCU/> with a photo of their pet dog(s). Use of any automated system to participate is prohibited and will result in disqualification. Participants may enter the contest once per week, with winners being drawn every week

3. Selection of Winner. The winners will be selected by random drawing from all eligible entries on July 3, 2025, July 11th, 2025, July 18, 2025, July 25, 2025, and July 31, 2025. The odds of winning are contingent upon the number of eligible contestant entries received during the entry periods from June 23, 2025 and ending July 31, 2025, with winners drawn each week. Clarity Credit Union will attempt to contact the winner(s) via a post or private message on the social platform that the entry was received on or via phone call at the number provided in their account information. If the prize is not claimed within 30 days, the prize is forfeited. The names of the winner(s) will be announced on Sponsor's Facebook accounts.

4. Prizes. Contestants have the opportunity of winning one (1) \$50 gift card or voucher that will be awarded individually in this contest. There will be one (1) winner chosen. All sales, prize and other taxes, gratuities and any other incidentals associated with the prize are the sole responsibility of the prize-winner. Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability. In which case, a prize of equal or greater value will be awarded.
