

# OFFICIAL CONTEST RULES

1. **Contest Dates/Eligibility.** Clarity Credit Union is in charge of the Fall Lowe Family Farmstead Ticket Giveaway 2025. The contest, beginning October 1, 2025, and ending October 10, 2025 will include one drawing on October 10, 2025. We retain the right to change the dates and/or the terms of the contest without prior notice. There is no purchase necessary to enter or win. A purchase will not increase a contestant's chance of winning. This contest is void where prohibited by law. Employees or agents of Clarity Credit Union, or any entity associated with the sponsorship or administration of the contest, are ineligible to participate.
2. **How to Enter.** Beginning October 1, 2025 and continuing until October 10, 2025, participants must leave a comment on our contest post at our Facebook page <https://www.facebook.com/ClarityCU/> about their favorite part of the Autumn season. Use of any automated system to participate is prohibited and will result in disqualification. Participants may enter the contest via one comment, and only one comment will qualify participation. Extra comments will not be counted.
3. **Selection of Winner.** The winners will be selected by random drawing from all eligible entries on October 10, 2025. The odds of winning are contingent upon the number of eligible contestant entries received during the entry period from October 1, 2025 - October 10, 2025. Clarity Credit Union will attempt to contact the winner(s) via a post or private message on the social platform that the entry was received on or via phone call at the number provided in their account information. If the prize is not claimed within 30 days, the prize is forfeited. The names of the winner(s) will be announced on Sponsor's Facebook accounts.
4. **Prizes.** Contestants have the opportunity of winning four (4) Saturday Admission tickets to the Lowe Family Farmstead that will be awarded together in this contest. There will be one (1) winner chosen. All sales, prize and other taxes, gratuities and any other incidentals associated with the prize are the sole responsibility of the prize-winner. Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability. In which case, a prize of equal or greater value will be awarded.
